The USDA Wholesome Meat Act applies to all slaughter animals at this fair. The act requires: (1) DES, Antibiotics and Sulfonamides have required withdrawal periods (2) Drug label directions must be followed. (3) If drug or chemicals are found in a carcass tissue, the entire carcass may be condemned and the exhibitor will forfeit awards and auction money. (4) If a carcass is condemned for any reason, the exhibitor will forfeit awards and auction money.
