Organized Youth Membership Completion Requirements Year 2011 – 2012

It is important that the Verde Valley Fair Organized Youth Group Clubs be a positive learning experience. In order to assure a degree of consistency or fairness, the following completion requirements have been established.

- Attend eighty percent (80%) of community club and project meetings held during the year (October 1st to September 30th). Note: A total of three (3) excused absences will be permitted to count toward attendance however a member may not claim more than eighty percent (80%) attendance during the year if two or more excused absences are taken. Excused absences include: illness (member or member's family), accident, school or church functions and employment obligations.
- Give a presentation at community club, project club, county or state event.
- Participate in at least one judging or field day (small stock, large stock, non-livestock, etc.)
- Participate in a minimum of six (6) hours of community service. Acceptance is subject to approval of the Community Club or Project Leader.
- Have no outstanding debt to the Verde Valley Fair Organized Youth Group Programs (fundraising dollars, bad checks, project materials, library materials, etc.)
- Once you have enrolled within a club, you are unable to switch clubs for one year.
- Obtain a copy of the 2012 Verde Valley Fair Livestock Rules. These rules should be thoroughly read and understood, and a completed entry form must be turned in by due dates.
- All Livestock, department and Verde Valley Fair Rules must be followed during the project year and while participating in the Fair.

The above stated requirements are minimums. Verde Valley Fair Community/Project Leaders may institute additional requirements, provided parents and members are notified in writing at enrollment. The Community/Project Leader is responsible for determining whether a member is in good standing. The Verde Valley Fair Association, Inc. will determine member status in a disputed case.

Youth Member Code of Conduct

The mission of the Verde Valley Fair Organized Youth Programs is: To provide education, entertainment, and a family atmosphere that is unequalled at the price and value. In fulfilling this mission, certain standards of behavior are expected of all participants and are also necessary to provide a positive learning environment for others. The following guidelines represent the Verde Valley Fair Association, Inc. Leader and Youth Member Code of Conduct:

- Participants will refrain from all forms of lying, deception or omission
- Participants will attend all assigned or enrolled sessions of planned events except in the case of illness or scheduling conflicts, provided adult(s) in charge are notified.
- Participants will operate within an all inclusive atmosphere
- Participants will refrain from all forms of hazing and/or harassment
- Participants will show appreciation for the efforts of others
- Participants will follow all state and local laws at all times
- Participants will follow all rules and regulations established for any organized youth related event
- Participants will refrain from the use of any illegal substance including alcohol or tobacco during organized youth group activities
- Participants will exhibit respect for the environment
- Participants will be on time to all program events
- Participants and/or their parents or legal guardians will be responsible for any damages, theft or misconduct in which they may participate.
- Participants will dress appropriately and tastefully at all events
- Participants will refrain from the use of vulgar and/or abusive language
- Participants will treat all equipment, vehicles or property with respect and treat animals humanely
- Participants will not permit nor will they participate in statements or acts of prejudice
- Participants will at all times be just, fair and open
- Participants are not eligible for the Verde Valley Fair Association, Inc. organized youth group program should immediate family members, i.e. father, mother, sister(s), brother(s), grandparents, and spouses, etc., incur debts to the Verde Valley Fair Association, Inc. and are ineligible for participation in said program until all debts are paid in full
